The Position

The Post Acute Care (PAC) team provides short term supports to facilitate a safe and timely discharge from hospital, while offering connections to longer term services when needed. Clients discharged from a public hospital – including emergency departments, acute care and sub-acute services are eligible for these short term supports.

As part of the PAC nursing team, you will be expected to practice autonomously. You will be required to consult, liaise and advise with other services internally and externally to Bendigo Health to enable coordinated and appropriate client care following a hospital discharge. In addition to providing direct care you will provide non clinical support to the program and empower clients and/or carers to be actively involved in their care.

Responsibilities and Accountabilities

As part of the PAC nursing team you will be responsible for all areas of the PAC nursing process, from intake and triage through to direct client care and timely discharge.

Key Responsibilities

- Triage and management of incoming and current referrals
- Comprehensive assessment of eligible clients including supportive care plans that facilitate client empowerment and commitment to active participation in their healthcare
- Provide support, information and healthcare education that reflects the client's individual needs, preferences and abilities
- Respond to clinical changes in a client's condition/care needs and initiate consultation with relevant medical, nursing and/or allied health professionals
- Initiate and maintain accurate records, statistics and reports
- Ensure clients are linked into ongoing services/supports in the community as required
- Work collaboratively and liaise with multidisciplinary teams including internal and external parties
- Active participation in Quality Standards, staff development, training/supervision, program planning and evaluation processes
- Identify and manage risks associated with working in the community setting, ensuring safety of clients and staff
- Undertake any additional tasks or provide support as directed by your manager, ensuring these activities align with your professional standards, codes of conduct and ethics and organisational policies

Key Selection Criteria

Essential

1. Registration (RN Division 1) with the Nursing and Midwifery Board of Australia (Australian Health Practitioner Registration Australia – AHPRA)
2. Minimum 3 years' experience in nursing, post registration, in a clinical environment preferably with recent experience in a community setting

3. Demonstrated ability to work autonomously with minimal supervision to provide high quality client care

Desirable

4. Demonstrated ability to be self-motivated with high level skills in problem solving and time management

5. Demonstrated wound care knowledge and highly developed wound care assessment skills

6. Demonstrated high level communication skills including written, verbal and interpersonal abilities with the capacity to engage clients, families and multidisciplinary teams

7. Strong computer literacy skills to support the programs' ability to maintain schedules, make referrals and communicate with the team

8. Strong knowledge of the services available to support clients in their home and referral process

9. A demonstrated commitment and understanding of holistic and evidence-based care and patient advocacy
