The Position

The Registered Nurse collaborates with Nurse Unit Managers, Enrolled Nurses, and Health Care Workers to provide person-centred, recreational-based care and specialist behaviour support within the Specialist Dementia Care Program (SDCP). This temporary care unit aims to stabilise and reduce severe behavioural and psychological symptoms, facilitating a supported transition to less intensive, mainstream residential care settings. The SDCP team works closely with Dementia Support Australia, Dementia Training Australia, and specialist clinicians to help individuals achieve the goals and positive outcomes of the program.

Responsibilities and Accountabilities

In this role, you'll provide safe, person-centred nursing care focused on supporting residents through rehabilitation and behavioural stabilisation.

Key Responsibilities

- To practice within the Nursing and Midwifery Board of Australia NMBA competency standards
- Provide and promote safe, recreational, person-centred, psychosocial, goal-orientated care, supporting residents to promote rehabilitation and build on their capabilities in an interdisciplinary environment with the aim of transitioning out of the SDCP following stabilisation.
- Consult with the health care team, resident and carers to assist and supervise the planning, delivery and evaluation of a high standard of quality person-centred nursing care.
- Promote practices, that complies with the policies and procedures of BH and actively participates in the maintenance and implementation of relevant BH policies and procedures to ensure best practice.
- Provide and promote effective communication that includes the resident, carers and inter - disciplinary team within and external to Bendigo Health.
- Contribute to the collection of relevant clinical data as required for SDCP KPI's and guidelines.
- Refer relevant and important issues to the Associate Nurse Unit Manager or Nurse Unit Manager or other health care team members.
- Ensure the safe operation and cleanliness of all clinical equipment according to relevant standards.
- Ensure compliance with BH risk management policy and guidelines.
- Ensure compliance with Food Safety Program Guideline.
- Participate in staff development and training as required under the National Dementia Education and Training Standards Framework for SDCP staff (including annual mandatory training in fire/emergency, cardio-pulmonary resuscitation, infection control & 'safe manual handling'), and maintain a personal record of activities completed.

- Maintain a practical working knowledge of Aged Care Act legislation inclusive of the Aged Care Quality Standards.

Residential services specific activities

- Ensure a current understanding of contemporary issues and practices affecting the holistic management of residents (i.e. complex physical needs of residents, managing behaviours relating to dementia/depression, younger people with acquired brain injuries).
- Maintain a current knowledge of the documentation required for Aged Care and ensure their implementation to optimise resident outcomes.
- Maintain a practical working knowledge of Aged Care legislation inclusive of the Aged Care Quality Standards
- Notify your employer and document all incidents of alleged or suspected assaults (including unreasonable use of force and unlawful sexual contact) so that the appropriate response can be undertaken to ensure the health, safety and wellbeing of residents, and to meet record keeping responsibilities under the Act.
- The law also requires staff to report missing residents in certain circumstances so Bendigo Health can respond in line with legislation.

Key Selection Criteria

Essential

1. Current registration with the Nursing and Midwifery Board of Australia through the regulatory body, Australian Health Practitioner Regulation Agency (APHRA) with a minimum of 1 year full time or PPT equivalent experience practising in a residential or inpatient care setting
2. Experience in aged care or inpatient care, especially caring for people living with dementia and understanding of behavioural and psychological symptoms of dementia (BPSD)
3. Demonstrated knowledge and experience in quality improvement and the Aged Care Quality Standards
4. Demonstrated ongoing commitment to professional development and a demonstrated high level of motivation and willingness to learn
5. Ability to work collaboratively within a team environment
6. Previous experience providing a recreational, person-centred, psychosocial, goal-orientated care, supporting residents to promote rehabilitation and build on their capabilities.

Desirable

7. Working towards or possessing relevant post registration qualifications such as Dementia or Gerontology
8. Previous experience working in a Specialised Dementia Care Program (SDCP)
9. Sound understanding of Food Safety or current Food Safety certificate
