Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Digital Services Division

The Digital Services Division is charged with delivering technology solutions that deliver on our vision. As well as responsibility for the mainstream ICT services and support the division encompasses ePR project, Project Management Office, Clinical Analytics and associated resources including the Chief Clinical Information Officers.

The Division leverages ICT technologies and expertise to provide the technical foundations for innovation and transformation of our clinical service delivery. Critical to this is the successful implementation of an ePR in the acute setting and the development of innovative ways to use the data this will create. The Division is instrumental in building a strong culture of utilising health informatics and using data to drive innovation.

The Architecture and Applications Department

The Architecture and Applications department manage the implementation, consolidation, integration and development of corporate and clinical information systems at Bendigo Health. The team is responsible for the development, maintenance and availability of applications within Bendigo Health. The team is split into three functional areas. Two areas focus on delivery of services and products (applications) to their users. The third, focuses on the overall effective management of the BHCG portfolio of applications (software), understanding what we have, why and for whom.

Loddon Mallee Shared Services

The Loddon Mallee Shared Services (LMSS) model provides for a single Regional Chief Information Officer who oversees delivery of the core and non-core services to all members of the Loddon Mallee Rural Health Alliance (LMRHA). The services delivered by the LMSS enable a supported delivery of core services to all Agencies within the region, and access to non-core services as required, whilst leveraging its position to engage services to support all Agencies.

The Virtual Care Office

Working under the governance of the Loddon Mallee Shared Services and the Loddon Mallee Health Network, the Virtual Care Office is a regional service providing governance and guidance to the Loddon Mallee region on Virtual Care initiatives. The Virtual Care Office delivers initiatives to the region, that enable care to be delivered in new ways. The office works collaboratively with all LMHN health services and engage actively with clinicians and consumers to achieve optimal outcomes.

The Position

The Virtual Care Technical Specialist work alongside the Virtual Care Office Manager to deliver Virtual Care initiatives, such as Remote Patient Monitoring. They will performing an integral role in establishing the region's Virtual Care capability, with a focus on the technical systems and equipment that enable Virtual Care.

Responsibilities and Accountabilities

Key Responsibilities

The Virtual Care Technical Specialist will be responsible for the following:

- Lead the implementation of new technology from requirements gathering through to implementation and enhancement phases, coordinating the technical activities and providing robust documentation of all work undertaken.
- Identify opportunities for system enhancements and deliver through facilitated consultation with regional clinical services.
- Develop and deliver systems training content for clinical services for all Virtual Care initiatives.
- Complete necessary system testing, including the facilitation of user acceptance testing with relevant business owners. Provide robust documentation for testing scenarios and sign off from business owners.
- Provide support function for existing Virtual Care functionality within Regional Platform.
- Align processes to Regional Community Platform team, creating and fostering strong working relationships
- Develop and maintain contemporary knowledge of Virtual Care technology, acting in an advisory capacity for the Virtual Care Office Manager on future technology selection.
- Provide a range of secretariat and administrative services, including coordinating meetings, facilitation of workshops and preparation of papers.
- Travel as required across the region, supporting relevant project activities.
- Develop project communication plans, including communication with all project stakeholders
- Develop, implement, and support project change management activities and initiatives

Generic Responsibilities

Confidentiality - All information concerning Bendigo Health, its patients, clients, residents and staff should remain strictly confidential. Any unauthorised disclosure of such information may result in disciplinary action.

Quality Improvement - Bendigo Health is dedicated to improving the quality and safety of health services by providing care within the following domains of quality: Consumer Participation, Clinical Effectiveness, Effective Workforce and Risk Management. As a result, we apply the concept of the quality cycle for all our quality activities, initiatives and projects thereby ensuring the best possible care and treatment results are achieved. The underlying principle of the cycle is that an activity is not complete until evaluation shows that it has been effective and reached the desired outcome. As a Bendigo Health employee you have a responsibility to participate in and commit to ongoing quality improvement activities using the framework of the NSQHSS (National Safety and Quality Health Service Standards).
